## **Key Income Tax Related Proposals**

- withdraw outstanding direct tax demands
  - o pertaining to the period up to FY 2009-10 if demands is upto Rs. 25,000
  - o pertaining to the FY 2010-11 to 2014-15 if demands is upto Rs. 10,000 which is expected to benefit approx. 1 crore taxpayers
- New income tax regime to be default regime
- ☐ Retention of same tax rates:
  - · For direct taxes retained same for all assesses.
  - For Corporate Taxes-22% for existing domestic companies, 15% for certain new manufacturing companies
  - No tax liability for taxpayers with income up to ₹7 lakh under the new tax regime
- □ **Refunds at Lightning Speed:** Achieving efficiency milestones: The average processing time for returns has been significantly reduced from 93 days (2013-14) to a mere 10 days (2023-24).

- GST unifies fragmented indirect tax structures in India.
- Aims to reduce compliance burden on trade and industry.

 Recent survey by a leading consulting firm: 94% of industry leaders view GST transition as largely positive.

## Impact of GST on Indian Indirect Tax Regime

#### Financial Impact:

- Tax base of GST more than doubled.
- Average monthly gross GST collection nearly doubled to ₹1.66 lakh crore this year.



- States' SGST revenue achieved a buoyancy of 1.22.
- Contrasted with the pre-GST period, where tax buoyancy for state revenues was only 0.72.



#### **Consumer Benefits:**

- Reduction in logistics costs.
- Prices of most goods and services decreased, benefiting consumers.

## Continued boost-up for Startups

- A fund of Rs. 1 lakh crore will be set up to provide loans at low or zero interest rates, aiming to incentivize the private sector to amplify research and innovation in emerging sectors
- Ensuring timely financial aid, FM highlighted training for MSME to enhance global competitiveness, coupled with a commitment to next-gen reforms for unprecedented growth towards a developed India by 2047.
- 100% profit tax rebate for eligible startups in the first 3 years of their initial 10-year operation, with an annual turnover cap of Rs. 25 crore. The definition of Eligible start-up changed to include a start-up which is incorporated post 1 April 2016 but before 31 March 2025 (erstwhile 31 March 2024)



### Transformative Measures for GIFT IFSC

- Extension of tax benefits to startups, some investments made by sovereign wealth funds, and exemption for businesses housed in the IFSC in GIFT City for another year till March 31, 2025.
- The sunset clause, granting tax exemptions to foreign investment funds keen to relocate to IFSC-GIFT city, is extended by two years to 31 March 2025.
- A single window IT system to be set-up for registration and approvals from IFSCA, SEZ authorities, GSTN, RBI, SEBI, and IRDAI.
- Empowered GIFT IFSC by delegating the registration/approval power that earlier lied with SEZ authorities to the IFSCA.
- More than 545 IFSCA entities registered at GIFT IFSC including 25 aircraft and shipping entities.

There is no existence of unreal things and no cessation of real things. The truth and nature of both aspects are verily observed and concluded by the philosophers and seers of truth.


